

# CURRICULUM VITAE

**Dr. David Ramos Muñoz**

Dr. David Ramos Muñoz is an Associate Professor at Universidad Carlos III de Madrid, and also regularly lectures at, and collaborates with the University of Bologna. Born in 1979, he graduated from Universidad Carlos III de Madrid in Law and Business Administration in 2003 as the top student of his class. After a 1 year experience doing International Taxation, and a 3 month stay at Freshfields Bruckhaus Deringer's London Office, after winning the (2<sup>nd</sup>) Freshfields Prize for the Best European Business Law Student, he started his academic career. With a Scholarship from the Royal College of Spain (established in 1364) he pursued his PhD at the University of Bologna; and got it with *Cum Laude* in 2009 with a thesis entitled *Securitization and Special Purpose Vehicles in a Transnational Setting. A Systemic View* (which he later adapted and published with a more palatable title).

His research received the Prize of Excellence for Young (below 45) Researchers by the Social Council at Universidad Carlos III in 2016. He has developed this research mostly in the fields of Financial Law, and Contract law and Arbitration. In Financial Law, he is the author of books such as *EU Financial Law*. Kluwer-CEDAM, 2016 (with Marco Lamandini); or *The Law of Transnational Securitization* Oxford University Press, 2010, as well as numerous book chapters, and articles in the *International and Comparative Law Quarterly*, *American Bankruptcy Law Journal*, *Columbia Journal of European Law*, *European Company and Financial Law Review*, *Capital Markets Law Journal*, or *European Company Law Review*, on subjects as varied as securitization, Shadow Banking, the Banking Union, or FinTech, but typically related to the basic legal institutions of financial markets. His research has benefitted from the European Central Bank (ECB) Legal Research Program on two occasions (2015 and 2016), and research projects for Banca d'Italia and CONSOB, the Italian supervisors of banking and securities markets respectively, on matters pertaining to the Banking Union, and on the confluence of bank resolution and investor protection.

In the field of Contract Law, Ramos Muñoz has focused mostly on Uniform Law and Arbitration, with publications in *Revista de Derecho Mercantil*, *Spain Arbitration Review*, or *Revista Española de Derecho Europeo*. His research has also led to fields at the crossroad between Private and Public Law, as in his publications on the relationship between fundamental rights and private law, in the *European Review of Private Law*, or the aspects of Tax Arbitration, with the International Bureau of Fiscal Documentation.

Aside from his work for the University Carlos III and University of Bologna David Ramos Muñoz has been a Visiting Fellow at Queen Mary University of London (2005), University of Arizona (2006), University of Bologna (2007 and 2008) and the London School of Economics (2010), and regularly participates in conferences around the world. He has done consulting work for the European Commission (on central bank operations, and their relationship with MiFIR) and the European Parliament (on FinTech), as well as for private institutions, on matters pertaining to the Law of Finance, Competition Law and Corporate Law. Dr. Ramos Muñoz is a fellow member of the Academic Board (ad *personam*) of the European Banking Institute (EBI), and a member of the European Law Institute (ELI).

Dr. Ramos Muñoz currently teaches of Corporate and Securities Law, Commercial Law, Credit and Banking and Financial Regulation (with a basis on International, European, Spanish or Italian law), in undergraduate as well as postgraduate programs in Spanish, English and Italian. He coached the Carlos III team for the Willem C Vis International Arbitration Moot for 10 years, including 2008, when they won the competition, and currently organizes Moot Madrid, the most renowned moot court competition in Spanish, between Universidad Carlos III and UNCITRAL. Dr. Ramos Muñoz also co-directs the Master in International Advocacy at Universidad Carlos III de Madrid, where training in soft skills, international law, and moots and case studies (simulations of international transactions) are key to implement a practical and analytical teaching style.

Ramos Muñoz is an Alternate Member of the Appeal Panel for the Single Resolution Board (SRB), a member of the Madrid Bar, and the Madrid Arbitration Court, and has experience as single arbitrator, party arbitrator and chairman in contractual and banking disputes. He is very happily married and has two wonderful children.
